

FREQUENTLY ASKED QUESTIONS

What sizes are available?

15 YD & 30 YD containers

When do I pay?

The Hauling Fee will be charged at the time of transaction. Additional charges occur if the user extends the pick up date; the weight of the material in the container exceeds the stated weight limit or items are either prohibited or carry additional fees. A pre-authorization deposit is required in case additional fees are incurred.

I am a homeowner; can I rent a dumpster?

Yes. Simply call Northeast Distributors at (800) 488-2890 and a customer services representative will be able to assist you.

Can I set up an account with Northeast Distributors for multiple sites and multiple containers?

Yes. Please call and speak to a customer service representative.

How far do I fill up the dumpster?

Level with the top.

What happens if I overload the dumpster?

Driver can refuse pick up and/or additional charges will apply.

How do I know the weight is accurate?

Each transaction will have a certified weight ticket assigned to it and the address of pickup location.

If I have a problem or need to reschedule pickup or delivery dates?

Call customer service at (800) 488-2890.

How long can I keep the dumpster?

Typical rental period is 7 days. The container will be picked up one business day after pick up request.

Is there a cost for additional days?

Yes. There is a small additional per day charge

If the weight exceeds the allowable weight limit will I be charged extra?

Yes. You will be charged a per ton fee for containers that are over the stated allowable weight limit.

PROCESS FOR ORDERING / REMOVAL

How do I rent a dumpster?

Simply call (800) 488-2890.

A typical container ordered on a Monday through Thursday will be delivered within 24 hours. Customers have the option to have a container delivered at a pre-arranged delivery date. The container pick-up date is set when the order is placed.

To change the delivery or pick up date call (800) 488-2890 for customer service.

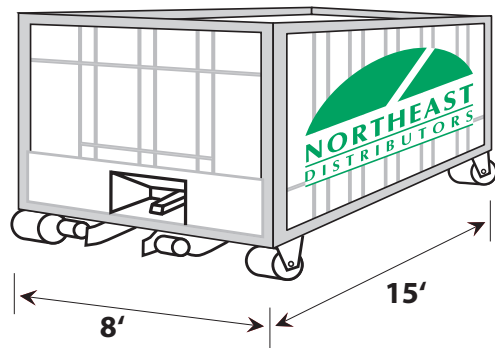

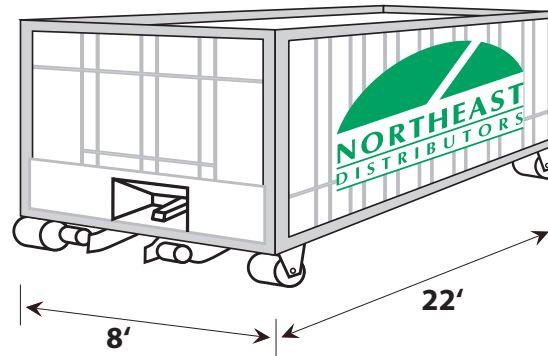

TERMS & CONDITIONS FOR DUMPSTER RENTAL

Waste Material – Customer represents and warrants that the materials placed in the equipment shall be “waste material” as defined herein and shall contain no other substances. The term “waste material” as used in these Terms and Conditions shall mean solid waste generated by Customer excluding radioactive, volatile, highly flammable, explosive, biomedical, infectious, toxic or hazardous material. The term “hazardous material” shall include, but not be limited to, any amount of waste listed or characterized as hazardous by the United States Environmental Protection Agency or any state agency pursuant to the Resource Conservation and Recovery Act of 1976, as amended or applicable by law. Title to and liability for any waste excluded above shall remain with Customer and Customer expressly agrees to defend, indemnify and hold harmless Contractor from and against any and all damages, penalties, fines and liabilities resulting from or arising out of such waste excluded above.

Driveways and Parking Areas – Customer warrants that any access / location provided for Contractor’s equipment is sufficient to bear the weight of all equipment and vehicles required to perform the service. Contractor shall not be responsible for damage to any pavement or accompanying sub-surface or any route reasonably necessary to perform the services herein contracted. In addition, Contractor shall not be responsible for damage to lawns, fences or shrubbery. Customer assumes all liabilities for damage to pavement or roads, lawns, fences and shrubbery.

Disclaimer

Due to the uncertain soil conditions and sub surface terrain, NED cannot be held responsible for any damage to customer driveways, curbs, lawns or walks, wells and septic systems. It is the customer’s responsibility to make NED aware of any utilities, which might be affected by taking delivery of the dumpster / container.

Due to inclement weather, traffic conditions or mechanical breakdowns, we cannot guarantee delivery times or dates.
